Terms and Conditions

These terms and conditions govern the functionality provided through this site. This document outlines important conditions that apply to your use of these services.  instructions are erroneous or insufficient in any way, we shall have no obligation or
 liability for the error.
- 3. Transaction Limitations. Certain types of bank accounts have limits on the numbers of transfers or withdrawals that may be made per month. Your bank may refuse debits that exceed such limits. Your bank may also refuse debits that exceed the amount of funds available. If we are not able to debit the amount required to cover an authorized payment and any fees from your account, we will not be able to make the payment you have authorized and will not be held liable for any costs, damages, etc. as a result of a failed transaction. We have no obligation to try to debit an account for a specific payment more than once.
- 4. Cutoff Hours. We will attempt to debit the funds from your bank account of payment authorizations from you the same business day or next business day. After processing with your bank, payments should be posted to your account on the following business day.
- Business Days. Business days for bank account debits are Monday through Friday, excluding banking holidays. Business days for crediting payment to your account are Monday through Friday. Our business days for customer service are Monday through Friday, excluding holidays.
- 6. **Authorized Users.** You must access the services with the appropriate Reference Number and License Plate. You may only authorize payments from bank accounts on which you are a signer. Any signer is authorized to make payments, even if your bank account otherwise requires two or more signatures for withdrawals.
- 7. **Confidentiality.** We will never sell any personally identifiable information to a third party without your consent. We will only disclose information to third parties about your account or the payments you make when it is:
 - Necessary for opening or maintaining your account or for completing transfers or payments,
 - Lawfully required or,
 - Requested or authorized by you.
- 8. **Fees.** Payments that are returned by your bank for any reason will be assessed a \$30.00 processing fee.
- 9. **Stop Payments.** Once you have given final authorization, the payment may not be canceled through our system. Contact your bank for assistance.
- 10. **Your Liability.** You agree to regularly and promptly review and verify all transactions through your bank's account statement or online activity reporting tools. If your bank statement shows transactions by us that you did not authorize, contact your bank.
- 11. **Our Liability.** If we do not complete payment in a timely manner in accordance with these terms and conditions, we will waive any late fees you may incur. However, there are some exceptions. We will NOT be liable, for example, when:
 - Your bank account does not contain sufficient available funds for us to debit the account in the amount of the payment authorized.

- The information you or your Other Payers have supplied to us is incorrect, incomplete or not timely.
